## The Maryland Episcopal Public Policy Network 2018 Legislative Wrap-Up

Each year the Maryland General Assembly meets for ninety days to debate legislative proposals and the state's budget. This year's session ended on Monday April 9<sup>th</sup> at midnight. Over 3,100 bills were introduced and 800 were passed and sent to the Governor for signing. Maryland Episcopal Public Policy Network (MEPPN) monitored, researched and wrote testimony and testified before committees regarding criminal justice issues, health care, environment, renewable energy jobs, homelessness, and gun control. This report is a brief summary of the bills that were addressed this session. For more information, please let me know.

Several of the bills addressed:

*HB* 736/SB 576 – *Pharmacy Benefits Managers* – *Pharmacies and Pharmacists* – Information about as well as sale of Prescription Drugs – Transparency of retail drug prices for consumers – Passed and signed by the Governor.

MEPPN's position: Support

*HB 888/SB 707 – Criminal Law – Firearm Crimes – Rapid Fire Trigger Activator* – Prohibition on rapid fire trigger activators in state - Passed and signed by the Governor. MEPPN's position: Support

SB 350 – Morgan State University – Task Force on Reconciliation and Equity – Creation of task force to foster reconciliation, racial equity and justice – Passed and signed by the Governor. MEPPN's position: Support

*HB 1224/SB 1218 – Ending Homelessness for Youth* – Grant program created to focus on preventing and ending youth homelessness in the Maryland – Passed and signed by the Governor. MEPPN's position: Support

SB 139 – Heroin and Opioid Addiction and Prevention Policies – Policy for all students attending UMUC, UMES and off-campus locations must receive information on heroin and opioid addition and prevention – Passed and signed by the Governor.

MEPPN's position: Support

*HB 1302 – Extreme Risk Protective Orders* – Process established for petitioner to seek a court order under certain circumstances – Passed and signed by the Governor. MEPPN's position: Support

*HB* 758 – *Public Safety* – *Handgun Permit* – *Guns in Churches* – Designating a person to carry a handgun in church – No vote taken by the Judiciary Committee.

MEPPN's position: Oppose

*HB* 760 – *Handguns* – *School Employees* – *Guns in Schools* – Designating a person to carry a handgun in schools – No vote taken by the Judiciary Committee.

MEPPN's position: Oppose
